



## Call for contributions towards the implementation of the capacity-building rolling plan

### Introduction

1. To further catalyse collaboration with other organizations in the implementation of the capacity-building rolling plan, the task force on capacity-building issued on 16 March 2018, with a deadline of 3 June 2018, a call inviting organisations to indicate whether and how they can contribute to the implementation of the three prioritised cross-cutting areas of its capacity-building rolling plan:
  - a. Supporting the use and uptake of approved IPBES assessments;
  - b. Developing guidance on national and (sub)regional science-policy platforms and networks; and
  - c. Supporting development and increasing use of learning materials on IPBES guides and assessments.
2. This document provides a short introduction to the call (section I) and a compilation of responses received through the call and other channels (section II).

### I. Call for contributions for the implementation of the IPBES capacity-building rolling plan

#### A. Supporting the use and uptake of approved IPBES assessments

3. Aim of call: The aim of this part a) of the call was to facilitate and develop capacities for effective uptake and use of the findings of approved IPBES assessments. This included raising awareness and appreciation among policy and decision makers, scientists, practitioners and other stakeholders about the key messages and policy options that have emerged from these assessments.
4. Invited submissions: Organisations were invited to:
  - a. Arrange stand-alone events focusing on approved assessments;
  - b. Add an element to, or align the agenda of, an already planned event to promote the uptake of approved assessments; or,
  - c. Pledge funds to support activities promoting the use and uptake of approved assessments.
5. Further process: Event organisers can be provided with communication and outreach materials subject to need and availability (e.g. a set of IPBES flyers, posters, electronic and/or printed copies of the IPBES summaries for policymakers (SPMs), standard presentations on IPBES and IPBES assessments, guides, outreach videos and FAQs) to support their activities. Based on the scope of the proposed event and available capacity, closer

collaboration might be considered (e.g. facilitation of participation of IPBES officials (physical or online), sharing templates for agendas, facilitation of sessions, providing social and traditional media support, etc.). The full list of events will be made available to the assessments' author teams to help them identify events in which they could participate.

6. **Recognition of contributions:** Contributions will be recognized on the IPBES website and reported to the IPBES Plenary for information. They may also be promoted on the IPBES social media channels.

#### **B. Developing guidance on national and (sub)regional science-policy platforms and networks**

7. **Aim of call:** The aim of this part b) of the call was to get access to lessons learnt on developing science-policy platforms and networks in the biodiversity and ecosystems-community and any other contexts that may provide lessons applicable to IPBES' efforts.
8. **Invited submissions:** Written input, be they documents, webpages, Wikipedia articles or similar, describing best practices, lessons learned and guidance that can be used to inform the development of the IPBES guidance on national and (sub)regional platforms and networks.
9. **Further process:** The input received will be used to develop guidance on IPBES' national and (sub)regional science-policy platforms and networks. If deemed relevant by the group, organisations responding to the call can be invited to take part in this process, for example by attending the planned third meeting of the IPBES capacity-building forum.
10. **Recognition of contributions:** Contributions will be acknowledged in the final IPBES' guidance document and reported to the IPBES Plenary for information.

#### **C. Supporting development and increasing use of learning materials on IPBES guides and assessments**

11. **Aim of call:** The aim of this part c) of the call was to develop an overview of available learning materials on IPBES assessments or guides to identify where there is a need for developing new materials and explore how to increase the use of existing learning materials.
12. **Invited submissions:**
  - a. Already completed learning materials about IPBES assessments or guides; or
  - b. Information on learning materials about IPBES assessments or guides to be developed in 2018-2019.
13. **Further process:** The task group on learning materials will use the input received in their further work to identify where there is a need for developing further learning materials and explore how to increase the use of existing materials. If deemed relevant by the group, organisations responding to the call can be invited to take part in this process, for example by attending the planned third meeting of the IPBES capacity-building forum.
14. **Recognition of contributions:** Contributions will be reported to the IPBES Plenary for information.
